





Background



- HIV care continuum : "beyond viral suppression", QoL as a transversal concept
- National HIV plan (2020-2026) : specific quality of life for plhiv objectives
- Reference to quality of life patient related outcome measures (prom) in the current NIHDI-HRC convention
- Prom : a means to comprehensively assess care outcomes and take into account the subjective experience of patients

Qol prom implementation at HRC

➤ Implementation principles:

- ✓ Frequency: yearly (longitudinal follow-up)
- ✓ Different data collection systems are used (EPD integrated, Redcap,...)
- ✓ The qol prom list will be translated in other languages
- ✓ 2025 will be a pilot year :
 - sharing and evaluating first experiences
 - tailoring prom setup to reach harder to reach populations
 - first data analysis
